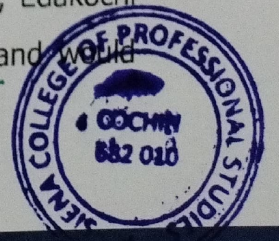

2. Each party will be responsible for its own cost in connection with all matters relating to collaborations under this MoU.





**Confidentiality**

**Tenure of the MoU**


