**NOW THEREFORE THIS MEMORANDUM OF UNDERSTANDING WITNESSES AS FOLLOWS**

Postgraduate Department of Commerce of Siena College of Professional Studies and Pinnacle GST Consultation & Training Centre recognize that the collaboration would be of mutual benefit and would provide Internship and Placement to students. As per the purpose of the said agreement, the responsibilities of two parties are:



## **I. Student Responsibilities**

- Internship Organization will maintain a safe, positive, and respectful learning environment for Student.
- Internship Organization will provide Student with on-going guidance and feedback during the course of the internship.
  - Certificates will be issued to the students those who successfully complete internship.

## **III. Costs**

2. Each Party will be responsible for its own costs in connection with all matters relating to collaborations under this MoU.

## **IV. Confidentiality**

3. The parties agree that there is no intention to share any confidential or proprietary information in any collaboration under this MoU. If either Party wishes to disclose information it considers being confidential or proprietary to the other Party, the Party needs to take prior written consent of the other party.

## **V. Tenure of MoU**

4. This MoU shall be effective for a period of three years from **18<sup>th</sup> February 2022** to **17<sup>th</sup> February 2025**, and can terminate or amend this agreement by giving the other Party a written notice one (1) month in advance during this period.
